There's a wall that runs through the West Bank. It gets called the 'security barrier', the 'separation fence', the 'annexation wall' and the 'apartheid wall'. The Israeli government says that the wall is a security measure to stop Palestinian terrorists coming into Israel from the West Bank. But the wall doesn't run along the green line — the border between the part of Palestine that became Israel in 1948, and the West Bank, the part that has been occupied since 1967 — the wall runs through the West Bank, separates Palestinian communities from each other, and annexes land from villages. Anarchists against the wall is a group of anarchists, who are Jewish citizens of Israel, that work together with Palestinian communities who've been affected by the wall. Their website www.awalls.org has regular updates on protest activities.

Clint Rickards, Brad Shipton and Bob Schollum were three New Zealand police officers who raped a number of women. In 2006 all three were acquitted of raping Louise Nicholas. The jury in the trial was not told that Shipton and Schollum were already in prison for a previous conviction of gang rape, because they had name suppression. After the trial people across Aotearoa broke the suppression order on blogs, through forwarded emails and by handing out leaflets. A year later the same men were acquitted of raping a third woman. That's when we marched to the High Court to protest the lack of justice for rape survivors. 
Dispatch from Anarchists Against the Wall:

Commemorating the Fall of the Berlin Wall, Demonstrators Tumbled Down Section of Wall in Ni'ilin

06/11/2009

This Friday, mass demonstrations held in Bil'in, Ma'asara, and Ni'ilin, marked the 20th anniversary to the fall of the Berlin wall.


In Ni'ilin, demonstrators brought down a section of the eight meters tall concrete wall that cuts through the village's land. The soldiers, positioned at the other side of the wall, fired scores of live rounds at the demonstrators as well as tear gas, and sprayed them with the "skunk-bomb" (a foul-smelling liquid). This is the first time since Israel began the construction of the wall in 2002 that demonstrators succeeded in toppling down a part of the wall. One of the demonstrators, Moheeb Khawaja, said during the protest: "Twenty years ago no one had thought the monster that divided Berlin into two could be brought down, but in only two days in November, it did. Today we have proven that this can also be done here and now. It is our land beyond this wall, and we will not give up on it. We will win for a simple reason — justice is on our side."




The time after Clint Rickards was acquitted of rape (again). We marched to the police station first, and the police had got all the



women officers to stand out front and guard the door. Maybe coz they knew our fury at male cops would not be contained just then. Vanessa stood up at the entrance to the police station, and read a statement about the rape she experienced in her life. Then she tried to walk inside, to file a complaint against the men who raped her. But the cops grabbed her and wouldn't let in. I've never seen so much rage. I think even we were shocked, that the police would stop a woman trying to report a crime committed against her.



Q's lawyer tried to argue that his client wasn't a threat to anyone's safety, and quoted the police's own intercepted evidence to make his point. The judge was not convinced. He quoted Q back at the lawyer, "I'm a revolutionary?" as if that one short statement clearly indicted Q as a menace to children, puppies, Christmas and all the known universes.
